No rebate will be awarded based on SEER rating listed on the HVAC dealer bid specifications, promotional material of dealer, manufacturer or any other source than AHRI.
- 4.) ALL homeowners must complete a rebate request form and provide proof of purchase to receive any 2018 Harrison REMC rebate. Deadline to apply for 2018 Rebate Program is Dec. 1, 2018.

2018 Rebate Request Form - HVAC Systems

→ Air Source Heat Pump or Mini-Split Heat Pump

(For installation in new construction or replacing any heating system EXCEPT 100% resistance heat.)

Dual/variable speed compressor: \$700 rebate

Other conditions to be met:

- Traditional stick-built and modular housing - **minimum 16 SEER rating**
- Manufactured/Mobile housing* - **minimum 14 SEER rating**
- Units that do not qualify include:
 - ▶ Window AC units or heat pumps
 - ▶ "Thru-the-wall" AC units or heat pumps (hotel-type machines)

Other conditions to be met for ductless mini-split are:

- Minimum 16 SEER rating
- Must be primary heating and cooling for the home
- Minimum of 2 indoor units per outdoor compressor bearing unit

Harrison REMC Only:

→ Air-Source Heat Pump or Ductless Mini-Split Heat Pump

(Replacing heating systems that used 100% electric resistance heat.)

Single speed compressor heat pump: \$750 rebate

Dual/variable speed compressor heat pump: \$1,450 rebate

Other conditions to be met:

** Mobile/manufactured homes are defined as:*

- Factory assembled; Transportable; Designed for transportation on own chassis; Can be placed on temporary or permanent foundation; Intended for year-round occupancy
- Note: Modular homes do not meet these requirements. Modular homes are considered residential single family homes.

→ Dual Fuel (fossil fuel furnace with heat pump)

Dual/variable speed compressor heat pump: \$1,000 rebate

Other conditions to be met:

- Traditional stick-built and modular housing - **minimum 16 SEER rating**
- Manufactured housing* - **minimum 14 SEER rating**

→ Geothermal Heat Pump

Geothermal incentive: \$1,450 rebate

- Rebate incentive requires a desuperheater installation for each geothermal system installed
